MISSION STATEMENT

The mission of Living Legends of Alexandria is to identify, honor and chronicle the lives of individuals who have contributed to the community in an exemplary and lasting way that has significantly impacted the quality of life in Alexandria and serves as an inspiration to others.

DEADLINE FOR SUBMISSION OF NOMINATIONS IS: September 30, 2018

NOMINATIONS CRITERIA

Living Legend Nominations will be evaluated based on how effectively they support the Living Legends mission and on either or both of the following criteria.

CRITERION 1: The Nominee has led the creation of something new or the redevelopment of something established that has significantly and positively impacted the quality of life in the City of Alexandria and inspires others.

AND/OR

CRITERION 2: The Nominee has demonstrated noteworthy, substantial, sustained, and inspirational contributions that have significantly and positively impacted quality of life in the City of Alexandria, through a significant period of years of service in leadership and/or project management roles, including on boards, commissions, and committees.

SUBMISSION OF NOMINATIONS

Nominators **MUST** ensure that the nomination addresses one or both of the above criteria, includes all of the requested information, and that all information is. Provide as many factual details and relevant examples as possible regarding the Nominee's contributions and their impact, since decisions on selected Legends are based only on the information provided.

Note: *Nominees need not reside in the City of Alexandria but must satisfy either or both of the below criteria. Only single individuals or a team of two persons working together are eligible to be nominated. If a team of two persons is nominated, they must be nominated for collaborating on the same innovation, project, program, or achievement. **Public employees are eligible** to be nominated, but the basis of their contributions should be **above and beyond the responsibilities of their jobs. Anyone running for or holding an elected office is not***

eligible for nomination. Current members of the Living Legends of Alexandria Board of Directors and any employees and agents of the organization are not eligible to be nominated.
